Dear citizen -

I am proud to present you with the Sarasota County Sheriff's Office 2021 Annual Report. This year, we took a different approach by substantially shortening and simplifying this document, highlighting a few interesting facts and plenty of statistics that showcase the incredible work of our sworn and civilian members. The last year was challenging for many as we continued to navigate the pandemic and pivot in response to changing times. Fortunately, despite global events, we feel more connected than ever to the community we serve.

In 2021, we launched two additional campaigns within our popular *How We Serve* series, hosted our first virtual career fair, earned re-accreditation and a new accreditation for our Drug Lab. We created a campaign focused solely on honoring our 911 calltakers, partnered with Sarasota County to halt the release of more than \$4 million in fraudulent CARES Act monies, and completed our 2021-2025 strategic plan. We partnered with the Charles & Margery Barancik Foundation to support re-entry programming in our correctional facility, launched a brand new social media video series, hosted two unforgettable community events, and so much more. I had the privilege of promoting several members to new ranks, congratulating personnel who earned their college degrees, attended advanced training, and were recognized by local congressmen. Members of my command staff earned board of director appointments with several local non-profit organizations, and we collected more toys than ever before for the children of Guardian Ad Litem during our 5th annual holiday toy drive.

While the impact of local law enforcement was tremendous, the profession itself saw a significant change with the transition from Uniformed Crime Reporting to National Incident-Based Reporting System (NIBRS). In its simplest form, on January 1, 2021, NIBRS completely changed how law enforcement organizations began reporting crime data to the FBI. The new formula is robust and details more specific details of crimes, which is helpful to policymakers and analysts. What this meant for SCSO is we had to essentially start from scratch with a brand new approach to data collection. It has been a learning curve for all of us, but we look forward to sharing new, more in-depth statistics with you in next year's annual report.

As I look ahead to 2022, I feel confident in our workforce and community. Sarasota County is unlike most communities around the state and country. The men and women of SCSO feel grateful to live and work among this great and growing community. Thank you for what you do every day to support the Sarasota County Sheriff's Office.

Six K-9 teams help keep the focus on crime prevention and public education throughout Sarasota County. K-9s and their handlers initiate missing person searches, apprehend fleeing criminals, conduct high-risk vehicle stops and article searches, perform drug odor and explosive detection, and more.

## **COMMUNITY PARTNERSHIPS**

When we talk about our culture, the first two words that come to mind are "community" and "service." Whether we are handing out turkeys on Thanksgiving, helping businesses build safety plans, supporting incarcerated men and women with job placement, talking to youth about decision making, or serving on boards of directors for local non-profits, everything we do is grounded in community. Fortunately for us, our community is pretty awesome.

Our Public Safety Communications Center (PSCC) is on the second floor of the Sarasota County's Emergency Operations Center on Porter Way in Sarasota. The PSCC is an intergovernmental partnership between SCSO, Sarasota County Government, and the 10 other law/fire/rescue agencies served. The county provides the equipment while the sheriff's office provides the manpower of 118 full-time positions. The men and women who make up the PSCC are truly Sarasota County's "first" first responders.
